RESOLUTION #95-27

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BETHEL AUTHORIZING THE CITY ATTORNEY TO INSTITUTE LEGAL ACTION TO ENSURE COMPLIANCE WITH THE CITY OF BETHEL SALES TAX ORDINANCE

WHEREAS, the City of Bethel levies a sales tax on sales made within municipal boundaries;
and

WHEREAS, the City relies on local vendors to collect and remit sales taxes levied by the City; and

WHEREAS, not all businesses in Bethel have either collected or remitted to the City sales taxes which should have been collected and remitted; and

WHEREAS, the City of Bethel sales tax ordinance requires sellers to make their books and records available for inspection by the City of Bethel, in order for the City to determine sales taxes have been properly collected and remitted to the City; and

WHEREAS, certain sellers have failed and refused to make their books and records available for inspection; and

WHEREAS, the City of Bethel has provided the sellers identified below with an ample opportunity to comply with the sales tax ordinance to no avail.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:




