A Public Hearing, under provisions of Ordinance #62, Section 52-14, was held at 8:10 P.M., August 26 1974, at the City Office. All Council members were present. Mary Gregory arriving at 8:35 P.M.

The meeting was called to order by Mayor Hoffman as a duly constituted Council.

M/M Richardson that the Council convert to a committee of the whole to hear testimony concerning cab rates.

Voice vote, unanimous in favor. motion passed.

After considerable discussion by Council, cab owners, accountants, cab drivers, dispatch operators and concerned members of the public was held.

The Council on m/m by Richardson and passed reverted to a Council from a Committee of the whole.

The Council was recalled to order by the Mayor and the following motion was made.

M/M Richardson that cab fares in the City of Bethel remain at \$1.50 in the City; \$3.00 to Airport; \$4.00 to BIA Site and that charter fare be \$20.00 an hour. Bus fares remain at:

Under 6 years of age	free
6-12 years of age	.50¢
12-18 years of age	.75¢
Over 18 years of age	\$1.00
To Airport	\$2.00

Until such time as the City Council under provisions of City of Bethel, Ordinance #62, Section 52-14, permits a raise in fares.

Motion failed by roll call vote, 4-3.

Voting aye: Connick, Murphy, Richardson. Voting nay, Crow, Gregory, Nicori, Hoffman.

M/M Crow that cab fares in the City of Bethel be \$1.25 in the City; \$1.50 to Hospital and trailer court; \$2.50 to Airport and \$3.50 to BIA Site and charter fare \$20.00 an hour. Bus fares remain at:

Under 6 years of age	free
6-12 years of age	.50¢
12-18 years of age	.75¢
Over 18 years of age	\$1.00
To Airport	\$2.00

Until such time as the City Council under provisions of City of Bethel, Ordinance #62, Section 52-14, permits a raise in fares.


