ORDINANCE #01-43

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO THE ATTACHED MEMORANDUM OF AGREEMENT WITH KREIDER SERVICES AND/OR KREIDER RENTALS TO COLLECT SEWAGE AND DELIVER WATER TO CERTAIN PROPERTIES IN THE CITY OF BETHEL

WHEREAS in 1991, the City Council entered into a Memorandum of Agreement with Kreider Rentals ("First Kreider MOA") authorizing it to evacuate, haul and discharge sewage at the City's sewer lagoon from rental units owned by Kreider Rentals; and

WHEREAS the City recently terminated the First Kreider MOA because Kreider Rentals was evacuating, hauling and discharging sewage for customers other than tenants in rental units owned by Kreider Rentals; and

WHEREAS Kreider Rentals no longer hauls and discharge sewage for such customers, and all of Kreider Rentals' former customers are now utilizing the City's sewer services and paying appropriate rates for those services; and

WHEREAS the City Manager has negotiated the attached Memorandum of Agreement with Kreider Services and/or Kreider Rentals ("Second Kreider MOA") to allow Kreider Services and/or Kreider Rentals ("Kreider") to collect sewage from and haul water to its own rental units on terms that are more favorable to the City than the First Kreider MOA; and

WHEREAS allowing Kreider to continue to provide such services to its own tenants on the terms and conditions provided for in the Second Kreider MOA is acceptable to the City;

BE IT ORDAINED by the City Council of Bethel, Alaska, that:

SECTION 1. Classification. This ordinance is not permanent or general in nature and shall not be placed in the Bethel Municipal Code.

SECTION 2. Chapters 4.20, 13.04, 13.08 and 13.16 of the Bethel Municipal Code shall not apply to the attached Second Kreider MOA.



SECTION 3. The City Council hereby approves the execution of the Second Kreider MOA, such approval to be effective for all actions of the City administration taken to negotiate it.

SECTION 4. Effective Date. This ordinance shall become effective immediately upon adoption and shall have retroactive effect back to the first date that the City administration began to negotiate the Second Kreider MOA.
