Hoffman recommended Chris Shantz.

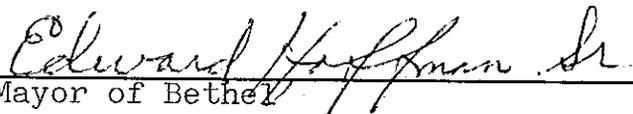
Hall recommended Pauline Chaney.
