

ORDINANCE #93-18

AN ORDINANCE OF THE CITY COUNCIL OF BETHEL, ALASKA, ESTABLISHING A CITY OF BETHEL BUDGET FOR FISCAL YEAR 1994 AND AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY COUNCIL OF BETHEL, ALASKA, AS FOLLOWS:

Section 1: That Ordinance #93-18, a non-code ordinance, establishing a City of Bethel budget for FY 94 in the form attached hereto is hereby adopted.

Section 2: That, per the attached budget document, sums of money necessary to defray all expenses and liabilities of the City of Bethel, are hereby appropriated for the corporate purpose and objects of the City of Bethel for fiscal year commencing on the first day of July 1993.

Section 3: That the FY 94 budget is adopted for a period of one (1) year, that being from July 1, 1993 through June 30, 1994.
