#### **A RESOLUTION CERTIFYING THE RESULTS OF THE JANUARY 19, 2010 SPECIAL CITY ELECTION**

**WHEREAS**, the Canvass Board of the City of Bethel met on January 25<sup>th</sup>, 2010 and tallied the votes of Questioned, Special Needs and Absentee ballots. **SECTION 3.** Proposition #3, Should the City of Bethel support a liquor license application for a restaurant or eating establishment within the City of Bethel? Was not supported.


**SECTION 4.** Proposition #4, Should the City of Bethel support a liquor license application of any other type within the City of Bethel? Was not supported.
