Special Meeting of October 25, 1994

I. CALL TO ORDER

The meeting was convened at 6:30 PM by Mayor Chris in the Log Cabin, Bethel, Alaska.

II. ROLL CALL

Present: Chris, Harding, Miller, Tubbs, Wintersteen

IV. CANVASS AND CERTIFICATION OF OCTOBER 24, 1994, MUNICIPAL RUN-OFF ELECTION RESULTS

The City Clerk reported that nineteen absentee ballots had been received, of which all nineteen were registered voters in Bethel, and, out of a total of 11 questioned ballots received, 8 were valid voters. The questioned ballots were verified by Region IV Elections Office.

motion M/M by Tubbs, 2nd by Wintersteen to disqualify the 3 questioned ballots in accordance with the State Election Law, as the voters were determined to be ineligible to vote in the current election. Voice vote. Motion carried unanimously.

Mayor Chris and Council members Harding, Miller, Tubbs, and Wintersteen tallied the ballots as the City Clerk read the ballots and the City Manager observed the reading of the ballots.

motion M/M by Tubbs, 2nd by Wintersteen to certify the results of the October 24, 1994, municipal run-off election as follows:

Buford McComas was then sworn in as a Council member.

Mayor Chris opened the floor to nominations for Mayor. Council member Tubbs nominated Allan Wintersteen for Mayor. There being no other nominations, Mayor Chris closed the floor to nominations.

motion M/M by Tubbs, 2nd by Miller to elect Allan Wintersteen as Mayor. Voice vote. Motion carried unanimously.
