## MUNICIPALITY OF BETHEL SPECIAL COUNCIL MEETING MAY 20, 1977

### COUNCIL CHAMBERS

7:00 P.M.

Meeting was called to order by Councilman Guinn acting as Mayor Pro Tem at 7:00 P.M. Present: Councilman Elliott, Guinn, Hickling, Hinsvark, Charles. Absent: Councilman Stichick, Peltola.

### APPROVAL OF AGENDA

M/M by Councilman Hinsvark to approve the Agenda for May 20, 1977. Voice vote was taken and was unanimous. Motion passed.

### NEW BUSINESS

#### ITEM A. CANVASING OF MAY 17, 1977, SPECIAL ELECTION RETURNS

Manager Bartlett read Title 2, Chapter.2.44, Section 2.44.320 of the Bethel Code of Ordinances pertaining to Canvassing, and Council serving as a Canvassing Board opened and counted Question and Absentee Ballots. M/M by Councilman Elliott that Council accept the vote of all registered voters confirmed by the Nome Election Supervisor as having registered thirty (30) days prior to the Special Election of May 17, 1977.

Councilman Guinn declared the results as follows:

M/M by Councilman Elliott to accept the results of the May 17, 1977, Special Election as declared by Councilman Guinn. Voice vote was taken and was unanimous. Councilman Guinn affirmed that the results of the May 17, 1977, Special Election had been canvassed and that Proposition No. 1 had passed.

- Item B. INTRODUCTION OF ORDINANCE NO. 99  
(AN ORDINANCE OF THE CITY OF BETHEL, PROVIDING FOR THE ISSUANCE AND SALE OF GENERAL OBLIGATION BONDS OF THE CITY OF BETHEL IN THE PRINCIPAL AMOUNT OF SEVEN HUNDRED AND NINETY-FIVE THOUSAND DOLLARS (\$795,000.00) FOR THE PURPOSE OF PAYING THE COSTS OF PLANNING, DESIGNING, CONSTRUCTING AND EQUIPPING THE BETHEL COURT BUILDING LOCATED WITHIN THE CITY OF BETHEL; FIXING THE DATE, FORM, TERMS, AND MATURITIES OF SUCH BONDS; AND PROVIDING FOR CERTAIN OTHER COVENANTS AND PROTECTIVE FEATURES)

Manager Bartlett introduced Ordinance No. 99, for a first reading and recommended that it be posted and a Public Hearing be established on Ordinance No. 99, on May 26, 1977, in accordance with the Bethel Code of Ordinances. M/M by Councilman Hinsvark that Council accept Ordinance No. 99 and that the Ordinance be posted in accordance with requirements as specified in the Bethel Code of Ordinances and that a Public Hearing be held on Ordinance No. 99, on Thursday, May 26, 1977, at 7:00 P.M. in Council Chambers. Roll Call Vote was taken. Yes: Guinn, Hinsvark, Charles, Hickling, Elliott. Motion carried

- Item C. INTRODUCTION OF ORDINANCE NO. 100  
(AN ORDINANCE OF THE CITY OF BETHEL, PROVIDING FOR THE BORROWING OF MONEY IN ANTICIPATION OF THE SALE OF GENERAL OBLIGATION BONDS OF THE CITY AND THE SECURING OF THE BOND ANTICIPATION LOAN BY THE ISSUANCE OF NEGOTIABLE NOTES)

Councilman Guinn introduced Ordinance No. 100, for a first reading. Manager Bartlett stated that the Bond Anticipation Loan was necessary as the General Obligation Bonds would not be sold for three to six months and that the initial interest on the Bond Anticipation Loan would be at a rate less than that of the interest rate on the General Obligation Bonds. Manager Bartlett further recommended that the title of Ordinance No. 100, be amended to read as follows:

(AN ORDINANCE OF THE CITY OF BETHEL, AUTHORIZING THE BORROWING OF MONEY IN ANTICIPATION OF THE SALE OF BETHEL COURT BUILDING GENERAL OBLIGATION BONDS APPROVED THE ELECTORATE ON MAY 17, 1977, AUTHORIZING THE ISSUANCE OF BOND ANTICIPATION NOTES, FIXING THE FORM, AMOUNTS, MATURITY, INTEREST RATE AND SECURITY THEREFORE, AND PROVIDING FOR A PRIVATE SALE.)

M/M by Councilwoman Charles that Council accept Ordinance No. 100 amended to read as presented by Manager Bartlett and that the Ordinance be posted in accordance with requirements as specified in the Bethel Code of Ordinances and that a Public Hearing be held on Ordinance No. 100, on Thursday, May 26, 1977, at 7:00 P.M. in Council Chambers. Roll Call Vote was taken. Yes: Guinn, Charles, Hinsvark, Hickling, Elliott. Motion carried.

M/M by Councilman Elliott to adjourn. Voice Vote was taken and was unanimous. Motion carried. Meeting was adjourned at 7:35 P.M.
