

ORDINANCE #93-04

AN ORDINANCE OF THE CITY COUNCIL OF BETHEL, ALASKA, AMENDING TITLE 2, CHAPTER 04, OF THE BETHEL MUNICIPAL CODE BY REVISING SECTION NO. 030 AND BY ADDING SECTION NO. 045.

BE IT ENACTED BY THE CITY COUNCIL OF BETHEL, ALASKA, AS FOLLOWS:

Section 1: Title 2, Chapter 04, of the Bethel Municipal Code is amended by revising Section No. 030.

Section 2: Title 2, Chapter 04 of the Bethel Municipal Code is amended by adding Section 045.

Section 3: This ordinance shall not be construed as abating any action now pending under, or by virtue of, prior existing laws or as discontinuing, abating, modifying, or altering any penalty accruing or about to accrue, or as affecting the liability of any person, or as waiving any right of the City under any section or provision existing at the time this ordinance is adopted, or as vacating or annulling any right obtained by any person, firm, or corporation, by lawful action of the City except as shall be expressly provided for in this title.

Section 4: If any part or provision of this ordinance or application thereof to any person or circumstances is adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part, provision, or application directly involved in all controversy in which this judgment shall have been rendered, and shall not affect or impair the validity of the remainder of this title or application thereof to other persons or circumstances. The City Council hereby declares that it would have enacted the remainder of this ordinance even without such part, provision, or application.

Section 5: Ordinance #93-04 amending Title 2, Chapter 04, Section 030 of the Bethel Municipal Code of Ordinances is hereby adopted as follows:

2.04.030 Order of business. Business shall be conducted in the following manner:

- a. Approval of consent agenda passes all items indicated by an asterisk on that agenda

Section 6: Ordinance #93-04, amending Title 2, Chapter 04 of the Bethel Municipal Code of Ordinances by adding Section 045 entitled Consent Agenda, is hereby adopted as follows:

2.04.045 Consent Agenda. Business requiring council action may be placed on a consent agenda for approval by a single motion. Resolutions that are not policy matters shall be placed for approval on the consent agenda. On the request of a council member an item placed on the consent agenda shall be removed from the consent agenda and shall be considered separately as the last item of new business.

Section 7. This ordinance shall take April 1, 1993
