APPROVAL OF AGENDA

M/M by Councilman Guinn to approve the Agenda for October 6, 1977, as presented. Voice vote was taken and was unanimous. Motion carried.

NEW BUSINESS

ITEM A. CANVASS OF RESULTS OF OCTOBER 4, 1977, GENERAL ELECTION

Council serving as a Canvassing Board opened and counted Question and Absentee Ballots. M/M by Councilman Guinn that the 28 absentee ballots which had been approved as registered voters be accepted. Voice vote was taken and was unanimous. Motion carried. Council proceeded to open the absentee ballots and tally the results. M/M by Councilman Guinn that the 34 question ballots in precinct one and the 17 question ballots in precinct two that were confirmed by the Nome election supervisor as having registered thirty days prior to the General Election of October 4, 1977, be accepted. Voice vote was taken and was unanimous. Motion carried. Council proceeded to open the accepted question ballots and tally the results.


