

RESOLUTION # 30

Whereas, the specific definition of the Bethel City limits is inaccurate, and

Whereas, the intent of the City's incorporators was to include everything within a 3-mile radius of N.C.Co in the City's limits, and

Whereas, it is the feeling of a large part of this community that the BIA site should be included in a new definition of the City's limits,

BE IT THEREFORE RESOLVED BY THE CITY COUNCIL OF BETHEL:

- (1) That the City adopt, upon the satisfaction of all legal requirements and State approvals, the following specific description of the square within which the said three-mile radius is inscribed, as the limits of the City of Bethel, to wit:

Beginning at latitude sixty degrees fifty minutes eight seconds North, longitude one-hundred sixty-one degrees forty minutes West, thence West 6.0 miles to latitude sixty degrees fifty minutes eight seconds North, longitude one-hundred sixty-one degrees fifty minutes thirty-five seconds West, thence South 5.88 miles to latitude sixty degrees forty-five minutes North, longitude one-hundred sixty-one degrees fifty minutes thirty-five seconds West, thence East 6.0 miles to latitude sixty degrees forty-five minutes North, longitude one-hundred sixty-one degrees forty minutes West, thence North 5.88 miles to latitude sixty degrees fifty minutes eight seconds North, longitude one-hundred sixty-one degrees forty minutes West, the point of beginning: Containing 35.28 square miles, more or less.

- (2) That the City annex, upon the satisfaction of all legal requirements and State approvals, the following described area, which includes the BIA site, to wit:

Beginning at latitude sixty degrees fifty minutes eight degrees North, longitude one-hundred sixty-one degrees fifty minutes thirty-five seconds West, thence West 2.50 miles to latitude sixty degrees fifty minutes eight seconds North, longitude one-hundred sixty-one degrees fifty-five minutes West, thence south 5.88 miles to latitude sixty degrees forty-five minutes North, longitude on-hundred sixty-one degrees fifty-five minutes West, thence East 2.50 miles to latitude sixty degrees forty-five minutes North, longitude onehundred sixty-one degrees fifty minutes thirty-five seconds West, thence North 5.88 miles to latitude sixty degrees fifty minutes eight seconds North, longitude one-hundred sixty-one degrees fifty minutes thirty-five seconds West, the point of beginning: Containing 14.70 square miles, more or less.

- (3) That a map description of this land, as shown on the USGS "Bethel C-8 and D-8 Quadrangle, 1954 Edition, be kept on permanent display in the offices of the City of Bethel.
