

CITY OF BETHEL, ALASKA

RESOLUTION NO. 98

A RESOLUTION PROVIDING FOR THE SUBMISSION TO THE QUALIFIED ELECTORS OF THE CITY OF BETHEL, ALASKA, THE QUESTION OF THE SALE OF INTOXICATING LIQUORS AT A SPECIAL ELECTION TO BE HELD IN AND FOR THE CITY OF BETHEL ON THE 2ND DAY OF OCTOBER, 1973.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BETHEL, ALASKA:

SECTION 1. IT IS HEREBY DETERMINED THAT MORE THAN THIRTY-FIVE PERCENT OF THE TOTAL NUMBER OF VOTERS AT THE LAST GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF BETHEL, ALASKA, HAVE PETITIONED THIS COUNCIL TO PLACE UPON A BALLOT AT A SPECIAL MUNICIPAL ELECTION, THE FOLLOWING QUESTION:

"FOR THE SALE OF INTOXICATING LIQUORS....." (YES OR NO)

ALL IN ACCORDANCE WITH THE PROVISIONS OF ALASKA STATUTES, SECTION 04.10.430.

SECTION 2. IT IS FURTHER DETERMINED THAT A SPECIAL ELECTION BE HELD ON THE 2ND DAY OF OCTOBER, 1973, IN AND FOR THE CITY OF BETHEL AND AT SAID ELECTION THE FOLLOWING PROPOSITION SHALL BE SUBMITTED UPON A SEPARATE BALLOT TO THE QUALIFIED ELECTORS OF THE CITY OF BETHEL:

SECTION 3. THE QUALIFICATIONS FOR ELECTORS AT SAID SPECIAL ELECTION ARE AS ESTABLISHED BY ALASKA STATUTES TITLE 15 AS FOLLOWS:

- (a) HAS PASSED HIS 18TH BIRTHDAY.
- (b) IS A CITIZEN OF THE UNITED STATES AND HAS BEEN A RESIDENT OF THE STATE AND OF THE ELECTION DISTRICT IN WHICH HE SEEKS TO VOTE FOR AT LEAST 30 DAYS JUST BEFORE THE ELECTION.
- (c) HE'S REGISTERED TO VOTE BEFORE THE ELECTION ACCORDING TO-

A S 15.07.010 - A S 15.07.200.

SECTION 4. THE POLLING PLACES WITHIN THE CITY ARE DESIGNATED AS FOLLOWS:

PRECINCT NO. 1: THE RECREATION BUILDING ACROSS FROM SWANSON'S STORE.

PRECINCT NO. 2: THE NEW BETHEL LIBRARY ON THE STATE HIGHWAY IN FRONT OF
THE OLD BRAUND BUILDING.

SECTION 5. THE SPECIAL ELECTION SHALL BE HELD BETWEEN THE HOURS OF
8:00 CLOCK A.M. AND 8:00 CLOCK P.M.

SECTION 6. PURSUANT TO THE REQUIREMENTS OF LAW, THE FOLLOWING ARE
APPOINTED JUDGES AND CLERKS FOR THIS SPECIAL MUNICIPAL ELECTION TO
SERVE IN THE MUNICIPAL VOTING PRECINCT AS SET FORTH. IN CITY OF
BETHEL ORDINANCE 46.

SECTION 6. IN THE EVENT ANY OF THE ABOVE ELECTION OFFICERS SHALL
FAIL TO TAKE THEIR OFFICE FOR ANY REASON, THE CLERK OF THE CITY OF
BETHEL IS AUTHORIZED TO APPOINT OTHER QUALIFIED OFFICIALS TO TAKE
THEIR PLACE IN THE MANNER PRESCRIBED BY LAW.

SECTION 7. AT LEAST TEN DAYS BEFORE THE DATE OF THE SPECIAL ELEC-
TION, THE CITY CLERK SHALL POST OR CAUSE TO BE POSTED A NOTICE OF
SPECIAL ELECTION IN THREE PUBLIC PLACES WITHIN THE CITY OF BETHEL,
ALASKA.

SECTION 8. THE FOREGOING NOTICE OF SPECIAL ELECTION SHALL ALSO BE
PUBLISHED AT LEAST TWICE IN ONE OR MORE NEWSPAPERS OF GENERAL CIR-
CULATION WITHIN THE CITY. FOR THE PURPOSES OF THIS RESOLUTION, THE
KUSKOKWIM KRONICLE IS DESIGNATED AS A NEWSPAPER OF GENERAL CIRCULA-
TION WITHIN THE CITY OF BETHEL. FIRST PUBLICATION IN THE NEWSPAPER
SHALL BE MADE NOT LESS THAN THIRTY (30) DAYS BEFORE THE ELECTION.

SECTION 9. ALL QUESTIONS OF VOTER RESIDENCE, QUALIFICATION AND

ELECTION PROCEDURES SHALL BE GOVERNED BY THE PROVISIONS OF ALASKA STATUTES TITLE 15, AND ORDINANCE NO. 46 OF THE CITY OF BETHEL, PROVIDED; HOWEVER, THAT IN THE EVENT OF A CONFLICT BETWEEN THE ORDINANCES AND THE STATE STATUTE, THE PROVISIONS OF THE STATE STATUTE SHALL BE FOLLOWED.
