Mayor Nicholson offered Ordinance No. 42 - AN ORDINANCE PROSCRIBING A COMPREHENSIVE SYSTEM OF CODES WHICH SET THE MINIMUM CONDITIONS UNDER WHICH BUILDINGS MAY LAWFULLY BE OCCUPIED- in its first reading.

That Council did not impose this ordinance upon the populace for any intent for immediate enforcement. It is Council's intent to comply with Federal requirements.
