
ITEM A. Introduction of Ordinance No. 96
(AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE QUALIFIED VOTERS OF BETHEL, ALASKA, OF THE QUESTION OF ISSUANCE OF \$795,000.00 OF GENERAL OBLIGATION BONDS OF THE CITY OF BETHEL TO PAY THE COSTS OF PLANNING, DESIGNING, CONSTRUCTION AND EQUIPPING THE BETHEL COURT HOUSE BUILDING LOCATED WITHIN THE CITY OF BETHEL, AT THE ELECTION TO BE HELD FOR THAT PURPOSE IN BETHEL ON MAY 17, 1977)

Mayor Peltola and Manager Bartlett stated this item was on the Agenda because Bond Counsel for the Alaska Municipal Bond Bank Authority, has stated that the Notice of Bonded Indebtedness posted for February, 22, 1977, Special Election contained an erroneous statement. The Bond Bank Legal Counsel is saying that a decision has been made not to approve the Bethel Bonds, until such time that Bethel proceeds to have another election with the Notice of Bonded Indebtedness being changed to read, "the total assessed valuation within the Municipality's boundaries is unknown because no ad valorem tax has to date ever been levied and no real assessment of property values has been made."

Manager Bartlett introduced Ordinance No. 96 for a first reading. M/M by Councilman Guinn that Council accept Ordinance No. 96 and call a Public Hearing, duly advertised or posted according to City Ordinance regulations, on April 21, 1977, at 7:00 P.M. Roll call vote was taken. Yes: Guinn, Peltola, Charles, Stichick, Hickling. Motion passed.

M/M by Councilman Guinn that the meeting be adjourned. Voice vote was taken and motion passed unanimously. Mayor Peltola adjourned the meeting at 7:25 P.M.
