October 9, 1997

I. CALL TO ORDER

The meeting was convened at 6:30 p.m. by Mayor Phillips at the Log Cabin, Bethel, Alaska.

III. PEOPLE TO BE HEARD

There were no people to be heard.

IV. APPROVAL OF THE AGENDA

motion M/M by O'Brien, 2nd by Richardson to approve the agenda as presented.

vote Voice vote. Motion carried, unanimously.

V. NEW BUSINESS: CANVASS AND CERTIFICATION OF ELECTION

The City Clerk explained the role of the Council in acting as the canvassing board, and asked for assistance from the Council in opening the absentee and questioned ballot envelopes, and sorting and counting of ballots. Mayor Phillips noted that a motion from the Council regarding the absentee and questioned ballots was in order.

motion M/M by Richardson, 2nd by O'Brien to accept the ballots cast by absentee and questioned voters correctly registered in Bethel.

Council members O'Brien and Richardson, and City Clerk Warren, tallied the votes for Propositions A, B, and C. 
