Voice Vote - Unanimous in favor. Motion passed

## CAIVASS OF SPECIAL ELECTION OF MARCH 19, 1974

The following eight (8) ballots were questioned: Donna Chris, Massillie Chris, Peggy Tikiun, Ben Charles, Helen Hubka, Don Heitt, Francine Heitt and Robert Leo Beans.

M/M Gregory to accept Ben Charles challenged ballot, registered in one precinct and voted in another.  
Voice Vote - unanimous in favor. Motion passed.

M /M Connick that Peggy Tikiun's ballot be accepted. Moved from Precinct 2 to precinct 1.  
Voice vote - unanimous in favor. Motion passed.

M/M Crow that Helen A. Hubka's ballot be accepted. Registered in precinct 1 and voted in 2. Voice note - unanimous in favor. Motion passed.

M/M Connick to accept Don and Francine Heitt's ballots. Registered in Anchorage.  
Voice Vote - unanimous in favor. Motion passed.

M/M Murphy to reject Donna Chris's ballot- Did not register in married name/  
Voice Vote - unanimous in favor. Motion passed.

M/M Murphy to reject Massillie Chris's ballot- No proof of registration.  
Voice vote - unanimous in favor. Motion passed.

M/M Murphy to reject Robert L. Bean's ballot- No proof of registration.  
Voice vote - unanimous in favor. Motion passed.
