STATE DISASTER ASSISTANCE

Mr. Bronson will file a report with the Governor's office concerning damage at Bethel. The Governor must declare the area a disaster area before any State assistance is available. The assistance is only available for non-insured property and is to be a source of last resort for the repair or replacement of damaged or lost property. A decision is expected from the Governor's office by October 14.






