ELLIOT Opened meeting at 9 P.M. Council members present, Elliot, Smit, Romer, Sallison, Guinn. Absent Christianson and Carpenter. Minutes of previous meeting read and approved. Elliot introduced new council members, Sallison and Romer.

No finance report. Treasurers Report \$16,210.70 Bank Balance.

Letter read by Elliot from Alaska Highway & Public Roads Dept. acknowledging letter on surveying garbage dump at Bethel.

Elliot advised public Council held special meeting with Abington on water purification unit. Parge leaving Anchorage latter part of week, Council purchased Water purification system from Alaska Plumbing and Heating in Anchorage, for \$5000.00 also materials for building for unit.

Weise suggested council hold special meeting to advise public on this water purification system on Friday at 8 p.m.

Smit announced meeting of Telephone Co on Monday evening to explore possibility of incorporation.

Senator Weise to explain Senate Bill 26. He feels we should wait until we get better representation of Village. Postpone until next meeting.

Nora Guinn made a motion Sarge Conick take Haleys place as City cop, while haley absent at same rate of pay if Haley gone for any length of time.

Romer seconded. 5 ayes 0 nays Motion carried.

Fen Smit advised Paul Dixon of the Dept of Aviation stated airstrip will be closed this fall.

Smit made motion to adjourn Nora Guinn seconded. 5 ayes 0 nays Motion carried.

3. On land belonging to Kieth Swanson near Anita Hoffmans house.

Howard Elliot to contact persons owning land for permission to use same for unit.

Write to the Alaska Dept of Health, Attention ^{Sgt} ~~Chief~~ Winey asking Dept's approval on procuring water from ~~the~~ west side of Slough.

Senator Weise announced on tomorrows charter there will be 40 passengers to tour the Town of Bethel and urges all residents to participate in activities.
