**PORT DIRECTOR REPORT -**

Lee: Added one category which is the budget financial-seeing where were are as of may 31<sup>st</sup>. Projected schedule for June since its one month behind -City Council has approved - the FY 09 budget. BC Contractors rep will be here next week, looking for materials to be here end of July first part of August. Survey of the small boat harbor was completed by McClintok, waiting for the report and the billing-had them send all the paperwork to me so the agreement between me and Ana Hoffman is that BNC will pay a quarter and the city pays three quarters. The bill is to be paid all by the city

and bnc will refund their portion, which the agreement between bnc and the city . Dana is selling a lot of SBH permits.

I brought in 2 types of plans - expansion of port office one was done local and one is prefab- look and see what is best- based on that. Then we can send on to the council I. council did include 50,000 starting at least to build or add on for the office-also did include 60,000 for a work boat I have found a boat --2 bids locally one from the prop shop and Swanson's we are waiting --- went to Dewy 's and found a sea ark -using it as a work boat- included in the port envelope is equipment list, other is a study on the enterprise fund- wasn't managed correctly, money shouldn't go into the general fund- we need a port fund that needs to be separate - recommend to the commission is to put forth a recommendation to the council taking this and establishing its own account in the same bank -so we cant play around with have a fund that we can use for the betterment of the port- finance can still do everything the same- for retirement payroll etc..... council will be the only ones to touch this account- right now in the BMC is the court house--thats the only on written in stone and in 2006- recommend to the commission to go forward that the council ---on this thing to go forward the council and they would look at this very strongly .

Tundy: I would ask for unanimously consent that the port director work on such a pkg and bring it back to the commission and then we forward it to the council and recommendation that way we will know that no one is playing with that money . Its all together separate from all the port budget and the enterprise fund is the upkeep of the seawall.

Question : Tundy: Any word since June 2nd<sup>d o</sup> on the city dock if Lyman has a answer from the state dot said they cannot tell anyone what happened with Lyman and the DOT commissioner. They are stone walling each other. Meantime, the dock is still sitting there and the DOT will divest themselves of it some way

shape or form whether that is good for Bethel we will see. When all members were here asking about some kind of paint we have the paint on board--- LADDERS-paint on board will be done this season. Blast your eyes will stand out- underneath - its on board

Harry: One thing we will need is reflector tape-

Lee: We are not going to do any painting until all they are done finishing putting up the new seawall.

ladder as part of the new sea wall project we will have to put in new ladders at the Petro port, put in more at the city dock ;and then we will do them all.

Lee: We talked about accountability for vehicles even though we are doing a port equipment list, the way to account for each vehicle how they are being used and time spent we know have logs for our heavy equipment as well as our small trucks for each vehicle and Pete's monitoring them on a some what daily basis. We should be able to see what we are spending on repairs, fuel and gas and who is operated it and why they operated it and did public works borrow it and for what reason and we will be able to better track what we have.

Harry: that is only the first step , the 2<sup>nd</sup> step is actually getting something for it.

But that is a good step.

Lee: you got to know where they are so you can recover them.

Harry: ya you find em every year when you dredge

Brandon: You cant leave a buoy hook to em?

Pete: well we do but that is what he is saying there all over the place.

Alan: at least that s what I know they are for—that way go right by them and you wont be having to hook on em.

Brandon: Well you hook and you pull it up and hook the cable to the end of the float right?

Harry: There all laid out here—buoy's here

Brandon: Ah but you have a cable that runs to the anchor why don't you just disconnect the buoy from the after you hook up the buoy

Pete: But what the buoy is on is the crown of the anchor so when you go to pull they can trip the line

Harry: What Brandon is trying to say is that we need longer buoy lines. Put the buoy's somewhere else.

Harry: Get filled in on the security and enforcement of small harbor now that we have been cut on labor-what is available and attendant or security

Lee: One person making tours from 5pm- midnight I have talked to the police chief about running to or three patrols-

Harry: can we get a check off list that we can get back from them saying that checked the boat harbor on this date and time , so that if there was an incident that we can have on file.

Lee: He and I are working on that.

Harry: Does that attendant have SBH license's for sale?

Lee: Yes

Pete: We are adding some attendants at the start of July the budge allows us to have 4 attendants a year

Lee: The budget allows me to have 4 port attendants one for winter, to work with Pete , work on floats inside -work at the sand shed

Harry: Starting now or in winter?

Lee: Some are starting now , got one already working, some are working through season until small boat harbor closes this winter, and bring another one on in the winter, that will work through out the winter with him and bring in the rest of them and work in may to finish the fiscal year.

Harry: Looking at the users of the boat harbor they require a place to park, life jackets, boat ramp working, and there is some kind of authority there to keep the peace and keep people from hiding from not buying permits, to conflicts. Very important to the users to see an attendant.

Pete: there should be coverage 16 hours a day 7 days a week and they have been told not to go past the Joe Lomack bldg there is not a reason for them to go to the Petro port they can see that Petro from Joe Lomack -

Harry: So the police dept as our back up from such a time forward just have them drive by or say they did -really doesn't work as much as someone parked by the ramp do a quick survey write something down and a piece of paper and moved on. People getting in the habit of seeing that that will deter them from doing this out of line. And it really doest cost the city more for doing that back when we had lots of attendants- people got too comfortable with there boats and now that the hand strings have been cut we would have a adapt to that-but it was very comfortable facility if we could get a little bit back-

Lee: Man coming out in July will look at the camera system. People seeing the cameras will help

Brandon: has one at the Petro dock has a good system. Will email lee his quote.

Pete: Police doesn't enforce any of that area---state troopers---city police--

Lee: Has tried to call the police and the dispatcher didn't respond to his call.

Brandon and Pete-Police problems

Brandon: why don't we fence in the small boat harbor? Might be far fetched?

Have gates? Fences are a great deterrent- cameras are great this time

have the sides fenced in-keeps people from stealing etc.....easy to maintain-

seized paperwork inlet salmon is in debt- has to pay what the city is owed


Lee: a bunch of small boats that are set up for auction Sam shields has all the paperwork
